

Pursuant to the provision of Article 69, Paragraph 1, Subparagraph 7 and Article 75, Paragraph 6 of the Electronic Media Act (Official Gazette, number 153/09, 84/11 and 94/13), the Council for Electronic Media adopts the

**ORDINANCE ON AMENDMENTS TO THE ORDINANCE ON  
THE REGISTER OF PROVIDERS OF MEDIA SERVICES, ELECTRONIC PUBLICATIONS  
AND PRODUCERS OF NON-PROFIT AUDIOVISUAL AND/OR RADIO PROGRAMMES**

Article 1

In the Ordinance on the Register of Providers of Media Services, Electronic Publications and Producers of Non-Profit Audiovisual and/or Radio Programme s (Official Gazette, number 134/13) Article 4 is amended and now reads:

The Book of concessions for the provision of television and/or radio services referred to in Article 3 of this Ordinance is to include the following information:

1. Number of the agreement
2. Name of the media service provider
3. Call designation
4. Type of program (television/radio)
5. Name of the authorised person
6. Headquarters of the media service provider
7. Telephone and fax numbers, e-mail and Internet addresses
8. VAT ID no. number of the media service provider
9. Programme basis (general/specialised)
10. Concession area
11. Name of programme network
12. Duration of the concession
13. ID of the Ministry of the Finance's agreement
14. Measures imposed by the Council's decisions
15. Date of adopting the decision on accepting the programme plan and prior approval to amendments to the programme plan
16. Role of the non-profit media service provider in accordance with Council's decision on granting the concession

Article 2

Article 6 is amended and now reads:

The book of On-demand Media Services Providers is to include:

1. Permit number
2. Name of the on-demand media service provider
3. Name of media service
4. Type of program (audio/television)
5. Name of the authorised representative
6. Headquarters of the on-demand media service provider
7. Telephone and fax numbers, e-mail and Internet address
8. VAT ID no. of the on-demand media service provider
9. Duration of the permit
10. Measures imposed by the Council's decisions
11. Role of the non-profit media service provider in accordance with Council's decision on granting the concession

### Article 3

Article 8 is amended and now reads:

The Book of Media Service Providers of Satellite, Internet, Cable and other Permitted Forms of Transmission shall record the following

1. Permit number
2. Name of the media service provider
3. Name of the media service
4. Type of programme (audio/audiovisual)
5. Name of the authorised representative
6. Headquarters of the media service provider
7. Telephone and fax numbers, e-mail and Internet address
8. VAT ID no. of the media service provider
9. Programme basis of the media service (general/specialised)
10. Duration of the permit
11. Measures imposed by the Council's decisions
12. Date of the decision on acceptance of the programme basis, i.e. prior approval on amendments to the programme basis
13. Role of the non-profit media service provider in accordance with Council's decision on granting the concession

### Article 4

A new Paragraph 2 is added to Article 10 that now reads:

(2) Exceptional non-profit electronic publications providers need not be enrolled in Register of Non-Profit Organization before the Ministry Finance if they are state budget users and are enrolled in Register of State Budget Users.

The previous Paragraph 2 becomes Paragraph 3 and after the words "Paragraph 1" the words "and 2" are added. The previous Paragraph 3 becomes Paragraph 4, which is amended and now reads:

(4) Evidence referred to in Paragraph 3 of this Article are considered the excerpts from the registers, certified states indicating that it involves a state budget user and the annual financial report.

The previous Paragraphs 5 and 6 become Paragraphs 7 and 8.

### Article 5

Article 11 is amended and now reads:

The Book of Electronic Publications Providers is to contain the following information:

1. Entry number
2. Name of the electronic publication provider
3. Name of the electronic publication
4. Name of the authorised representative
5. Headquarters of the electronic publications provider
6. Telephone and fax numbers, e-mail address
7. VAT number of the electronic publications provider
8. Address of the electronic publication (URL)
9. Measures imposed by the Council's decisions
10. Role of the non-profit electronic publication provider in accordance with Council's decision on entry into the Register

Article 6

Article 14 is amended and now reads:

The Book of Non-profit Producers of Audiovisual and/or Radio Programme is to contain the following:

1. Entry number
2. Name of non-profit producer
3. Type of programme that is produced (audio/audiovisual)
4. Name of the authorised representative
5. Headquarters of manufacturer
6. Telephone and fax numbers, e-mail and Internet addresses
7. VAT number of the manufacturer
8. Measures imposed by Council's decisions on refunding awarded assistance from the Fund

Transitional and final regulations

Article 7

This Ordinance comes into force on the eighth day of its publication in the Official Gazette.
